FACT SHEET



The European Network in Universal and Global History (ENIUGH) is organizing its 5th European Congress for World and Global History in cooperation with Central European University (Department of History), Corvinus University (Karl Polanyi Research Centre at the Institute of Sociology and Social Policy), and the Hungarian Academy of Sciences (Research Centre for Humanities). The congress takes place in **Budapest** from **31 August to 3 September 2017**.

Under the overall theme “**Ruptures, Empires, Revolutions**” and on the occasion of the centennial of the Russian Revolution, we will discuss the global context and repercussions of the revolution in particular while debating the role of revolutions in global history in general. Furthermore, we will explore empires and imperial forms of organization, especially in view of how they changed and ended, and which legacies they left. Violent transformations of societies, ruptures in world orders, and wars, as well as changing international relations are addressed from transnational and transregional angles.

As was the case at previous congresses a wider range of processes are discussed in terms of cross-border entanglements, circulations and transfers, including the production of knowledge, the development of international law, the reconfiguration of the international state order towards global governance structures, labour relations and historiography itself. Throughout the program, actor-centered perspectives range prominently.

During the four congress days more than 120 panels will take place, and we expect about 600 scholars, students and professionals from all over Europe and beyond.

The congress will open on Thursday, 31 August 2017, with a keynote lecture by Tamás Krausz (Eötvös Loránd University Budapest) on “Lenin on global history and the global historiography on Lenin”.

Furthermore, there will be **special events**, among them two roundtables, one on “Socialism and global history” and the other on “Revolution and religion”.

Parallel to the congress, internationally renowned publishing houses will present their work and authors to make and maintain contacts in **our publishers’ exhibition**.
